The Wealden (Parishes) Order 1990

Made .....	29th March 1990
Coming into force -	
for the purposes referred to	
in article 1(2)	30th March 1990
for all other purposes	1st April 1990

The Secretary of State, in exercise of his powers under sections 51(1) and 67(4) and (5) of the Local Government Act 1972(a) and all other powers enabling him in that behalf, hereby makes the following Order which gives effect with modification to proposals submitted to him under sections 47, 48(9) and 51(1) of that Act, more than six weeks before the making of this Order, by the Local Government Boundary Commission for England following recommendations made to them under section 48(8) of that Act by The Wealden District Council for proposals about parishes in the district:

## Citation and commencement

1.       -(1)       This Order may be cited as the Wealden (Parishes) Order 1990.

          (2)       This Order shall come into force on 30th March 1990 for any purpose set out in regulation 4(1) (coming into operation of order) of the Local Government Area Changes Regulations 1976(a).

          (3)       For all other purposes this Order shall come into force on 1st April 1990.

## Interpretation

2.       In this Order -

"boundary map" means one of the 20 maps prepared by the Department of the Environment, marked "Maps of The Wealden (Parishes) Order 1990", duly numbered for reference and deposited in accordance with regulation 5 of the Local Government Area Change Regulations 1976;

"county electoral division" means an electoral division of the county of East Sussex;

"district ward" means a ward of the district of Wealden.

### Creation of new parishes

3.       -(1)       There shall be created in the district of Wealden 6 new parishes as named in column 1 of Schedule 1 to this Order.

          (2)       Each new parish shall consist of the relevant area or areas named in column 2 of that Schedule.

### Consequential changes to electoral areas

4.       -(1)       The areas marked D1, D2, D3 and D4 on boundary map 10 shall be transferred to the Waldron district ward and to the Heathfield county electoral division.

          (2)       The area of the parish of Jevington, as constituted immediately before 1st April 1990, shall be transferred to the Willingdon district ward.

### Transfers between parishes

5.       -(1)       The area or areas marked on the boundary maps as shown in columns 1 and 2 of Schedule 2 to this Order shall be transferred from the relevant parish named in column 3 to that named in column 4.

          (2)       Where in column 5 there is named in relation to any area -

- (a)       a parish ward;
- (b)       a district ward;
- (c)       a county electoral division; or
- (d)       a petty sessional division -

that area shall in addition be transferred to that ward or division.

Parish councils for the new parishes

6.       -(1)       There shall be a parish council for each new parish created by article 3.

(2)       Subject to paragraph (3), the council of each new parish created by article 3 shall consist of the number of parish councillors shown in column 2 of the Table below.

(3) From 1st April 1990 until the fourth day after the ordinary day of election of parish councillors in 1991, the parish council of each new parish named in column 1 of the following Table shall consist of the persons who, immediately before 1st April 1990, held the office mentioned in column 2 -

(4) The proper officer of The Wealden District Council shall convene -

(a) the first annual meeting of the parish council for each new parish, which shall be held in April 1990; and

(b) the first assembly of the parish meeting for each new parish.

(5) If in any new parish the first assembly of the parish meeting is held before the first annual meeting of the parish council, that parish meeting may appoint a person to take the chair who shall have, for the purpose of that meeting only, the powers and authority of the chairman.

#### Expenses of new parish councils

7. For the financial year beginning on 1st April 1990, Wealden District Council shall set its personal community charge for each new parish, and make payments to the council of each new parish, as if that new parish had issued a precept to the district council requiring the payment of the sum which was approved by the district council for each new parish at the meeting of the district council held on 21st February 1990.

#### Consequential changes to district electoral arrangements

8. On 1st April 1991 -

(a) there shall be created a new district ward of Crowborough St Johns, consisting of the areas marked A4, A5 and A6 on boundary map 3, and represented by 1 district councillor; and

(b) the number of councillors representing the district ward of Withyham shall be reduced from 2 to 1.

9. The parishes named in column 1 of the table below shall cease to exist, their parish authorities shall be dissolved, and the residuary successor of each abolished authority shall be the authority of the relevant parish named in column 2 below, which authority shall also have custody of the public books and documents of that parish -

CREATION OF NEW PARISHES

Article 3

1 New parish of -	2 Formed from -
Chalvington with Ripe	the areas of the parishes of Chalvington and Ripe as constituted immediately before 1st April 1990.
Cuckmere Valley	the areas of the parishes of Litlington, Lullington and Westdean as constituted immediately before 1st April 1990 (but with the exception of those parts of Litlington marked A42 and A43 on boundary map 12 and that part of the parish of Westdean marked D7 on boundary map 13) together with those parts of the parish of Alfriston marked D5 and D6 on boundary map 12.
East Dean and Friston	the areas of the parishes of East Dean and Friston as constituted immediately before 1st April 1990, and that part of the parish of Westdean marked D7 on boundary map 13.

Long Man	the areas of the parishes of Folkington and Wilmington, as constituted immediately before 1st April 1990 (but with the exception of that part of Wilmington marked A57 on boundary map 16), and that part of the parish of Arlington which lies south of the line marked W - X - Y on boundary map 16.

## EXPLANATORY NOTE

(This note is not part of the Order)

This Order affects parishes in the district of Wealden.

It -

- (a) creates 6 new parishes from areas of existing parishes;
- (b) transfers areas between parishes; and
- (c) creates, on 1st April 1991, a new district ward of Crowborough St. Johns.

It establishes parish councils for the new parishes, and consequential changes to local government electoral areas and arrangements are made.

The Map forming part of this note (page ) gives a general guide to the areas affected. Prints of the detailed boundary maps (described in article 2) may be inspected at all reasonable times at the office of Wealden District Council and at the office of the Secretary of State for the Environment, 2 Marsham Street, London SW1P 3EB.

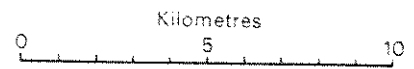
