

**LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH  
ACT 2007**

**The Northumberland (Reorganisation of Community Governance)  
(Parish of Heddon on the Wall) Order 2016**

Made 13<sup>th</sup> day of September 2016

Coming into force in accordance with article 1(2)

Northumberland County Council (“the council”) in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated February 2016:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by sections 86 and 240 of the 2007 Act.

**Citation and commencement**

1. (1) This Order may be cited as the Northumberland (Reorganisation of Community Governance) (Parish of Heddon on the Wall) Order 2016
- (2) Article 4 shall come into force on the ordinary day of election of councillors in 2017.
- (3) For the purposes of:-
  - (a) proceedings preliminary or relating to the election(s) of parish councillors for the parish of Heddon on the Wall, to be held on the

ordinary day of election of councillors in 2017, this Order shall come into force on 15 October 2016.

### **Intepretation**

2. In this Order -

“County” means the county of Northumberland

“Ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983; and

“Registration office” means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983”

### **Effect of Order**

3. This order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

### **Abolition of wards and number of parish councillors for the parish of Heddon on the Wall**

4. (1) The existing wards of the parish of Heddon on the Wall shall be abolished.
- (2) The number of councillors to be elected for the parish of Heddon on the shall be 9.

### **Electoral register**

5. The registration officer for Northumberland shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order

### **Order date**

6. 1st April 2017 is the order date for the purposes of the Local Government (Parishes and Parish Councils)(England) Regulations 2008.
