

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The South Cambridgeshire District Council (Reorganisation of Community Governance) Order 2011 relating to the Parish of West Wickham

Made this 14TH JANUARY 2011
Coming into force with article 1(2)

South Cambridgeshire District Council ("the Council"), in accordance with Section 82 of the Local Government and Public Involvement in Health Act 2007 (e) ("the 2007 Act"), has undertaken a community governance review and made recommendations dated the 17th January 2011.

The Council has decided to give effect to those recommendations and, in accordance with Section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The Council, in accordance with Section 100 of the 2007 Act, has had regard to guidance issued under that Section (f):

The Council makes the following Order in exercise of the powers conferred by Sections 86 and 240 (10) of the 2007 Act.

1. Citation and commencement(a)

- (1) This Order may be cited as the South Cambridgeshire District Council (Reorganisation of Community Governance) Order 2010 relating to the Parish of West Wickham.
- (2) It shall come into force on 5th May 2011.

2. Interpretation

In this Order –

"county" means the county of Cambridgeshire;

"district" means the district of South Cambridgeshire

"existing" means existing on the date this Order is made;

3. Effect of Order

This Order has effect subject to any agreement under Section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

4. Number of Parish Councillors for the Parish of West Wickham

The number of Councillors to be elected for the Parish of West Wickham shall be 7.

5. Order date

5th May 2011 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.
