

# LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

## The South Cambridgeshire District Council (Reorganisation of Community Governance) Order 2017 relating of the Parishes of Haslingfield, Grantchester and Hauxton

Made 13<sup>th</sup> day of March 2017

Coming into force in accordance with article 1(2)

South Cambridgeshire District Council (“the council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 26<sup>th</sup> January 2017:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by section 86 and 240(10) of the 2007 Act.

### **Citation and commencement**

1. (1) This Order may be cited as the South Cambridgeshire District Council (Reorganisation of Community Governance) Order 2017 relating of the Parishes of Haslingfield, Grantchester and Hauxton.

(2) It shall come into force on the day it was made.

### **Interpretation**

2. In this Order

“district” means the district of South Cambridgeshire.

“map” means the map marked “Map referred to in the South Cambridgeshire District Council (Reorganisation of Community Governance) Order 2017” and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

**Alteration of parish areas of Haslingfield, Grantchester and Hauxton**

3. (1) The area coloured pink on the map shall cease to be part of the parish of Haslingfield and shall become part of the parish of Grantchester.

(2) The area coloured yellow on the map shall cease to be part of the parish of Haslingfield and shall become part of the parish of Hauxton.

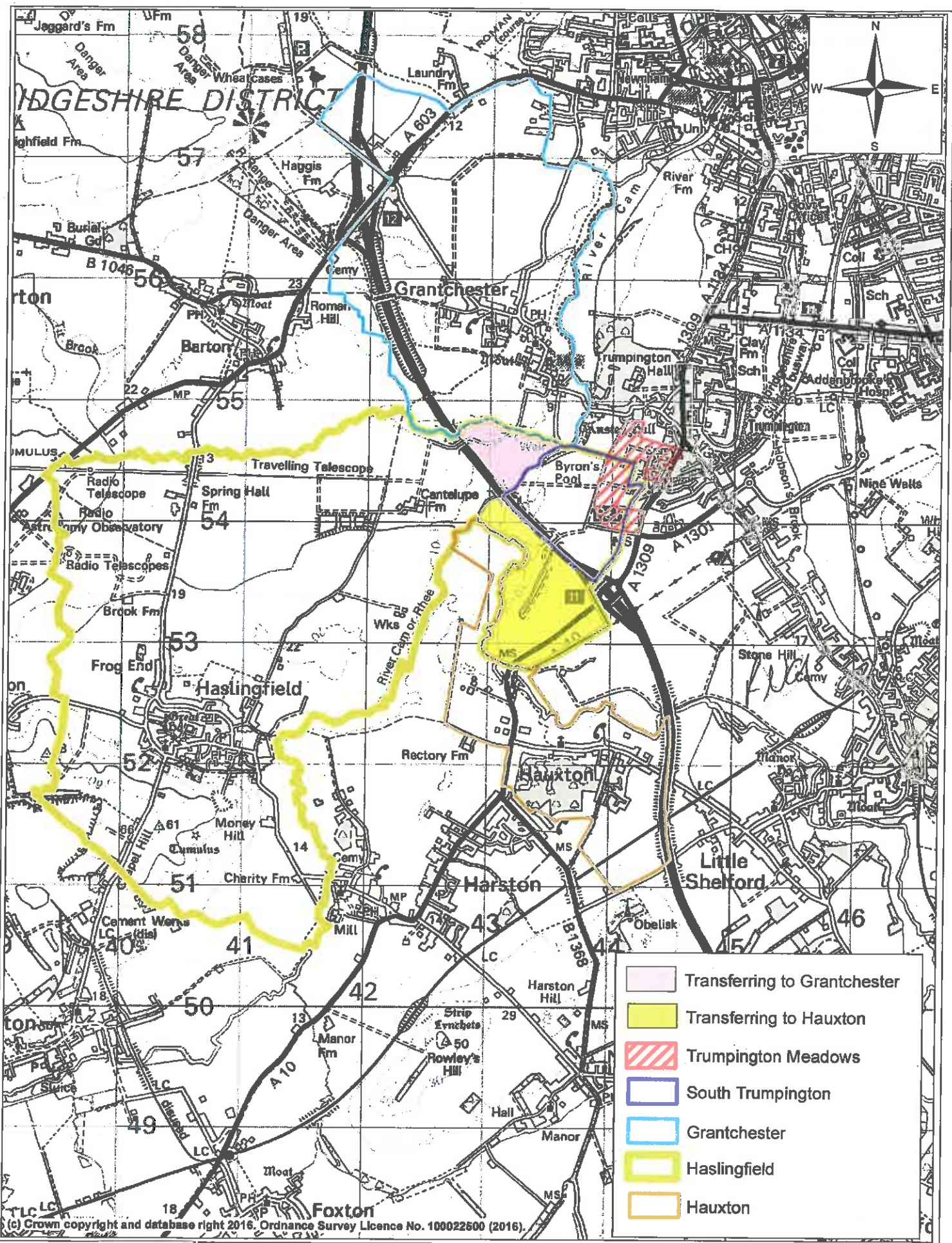
(3) The area edged purple on the map shall cease to be part of the parish of Haslingfield and shall become part of the newly created parish of South Trumpington.

**Order date**
