

# LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

## The South Cambridgeshire District Council (Reorganisation of Community Governance) (South Trumpington) Order 2017

Made 13<sup>th</sup> day of March 2017

Coming into force in accordance with article 1(2)

South Cambridgeshire District Council (“the council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 26<sup>th</sup> January 2017:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by section 86, 98(3) and 240(10) of the 2007 Act

### **Citation and commencement**

1. (1) This Order may be cited as the South Cambridgeshire District Council (Reorganisation of Community Governance) (South Trumpington) Order 2017

(2) It shall come into force on the day it was made

### **Interpretation**

2. In this Order

“district” means the district of South Cambridgeshire.

“map” means the map marked “Map referred to in the South Cambridgeshire District Council (Reorganisation of Community Governance) (South Trumpington) Order 2017” and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

“new parish” means the parish constituted by article 3

**Constitution of a new parish**

- 3. (1) A new parish, comprising the area edged and shaded blue on the map, shall be constituted within the district.
- (2) The name of the new parish shall be South Trumpington.

**Parish Meeting for the new parish**

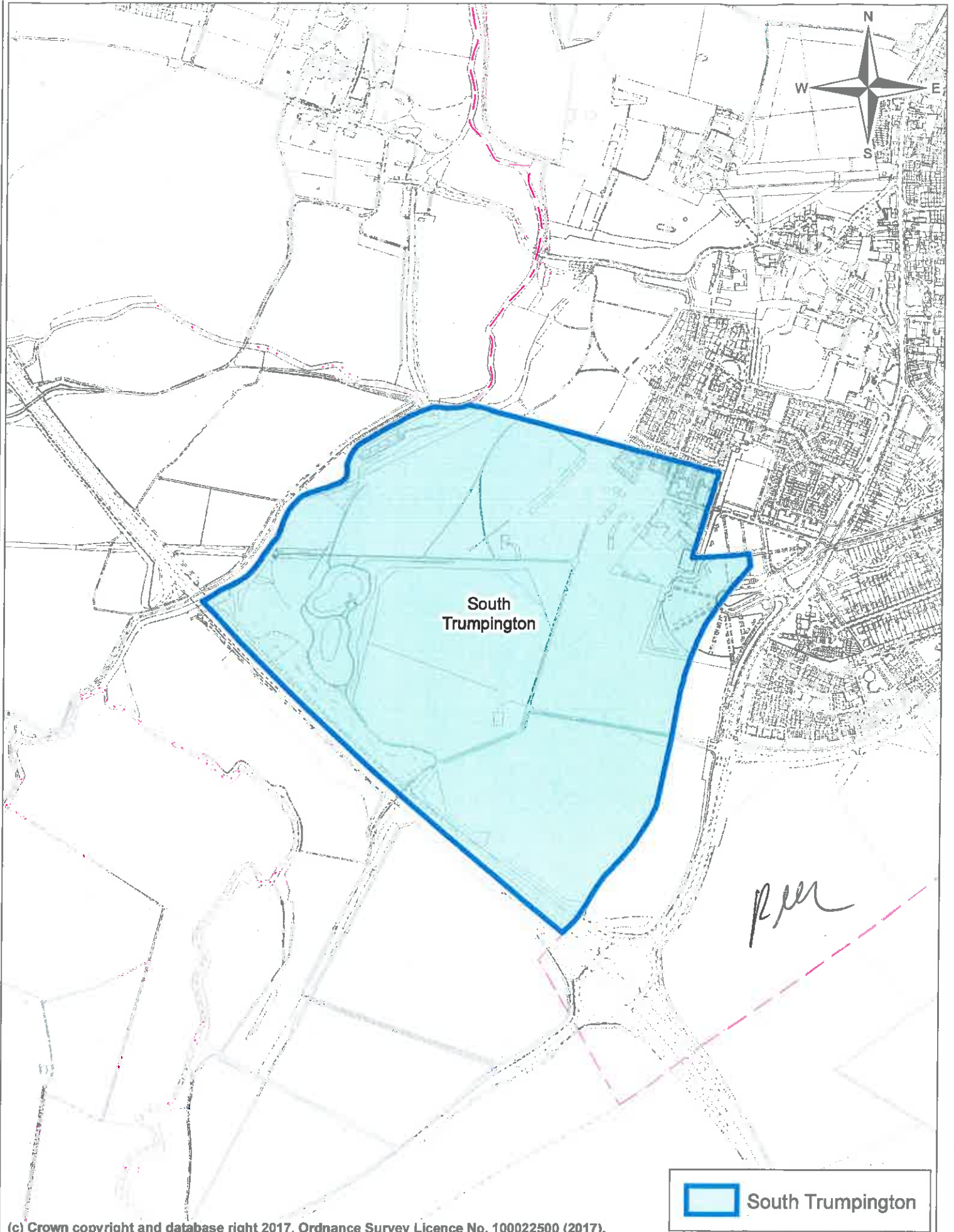
- 4. (1) A Parish Meeting shall be created for the new parish
- (2) The name of that parish meeting shall be South Trumpington Parish Meeting.

**Order date**

5 13<sup>th</sup> March 2017 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.
