Content

The UK NPM twitter account (@UKNPM) is managed by the UK NPM Co-ordination team, based in the offices of HM Inspectorate of Prisons (England and Wales). If you follow this account, you can expect several tweets each week covering information about and relating to the work of the UK NPM.

The feed will include relevant news on detention monitoring and conditions, news from our members, coverage of UK NPM meetings, events and publications, as well as coverage of relevant external events.

Retweeting will be used to highlight appropriate content that is relevant to the work of the UK NPM and our followers. Retweets and external links do not imply endorsement of messages, external organisations or individuals, unless otherwise specified.

We may use existing hashtags in order to categorise messages for ease of reference. Use of hashtags does not imply endorsement of any kind.

The UK NPM is made of up 21 member organisations. UK NPM tweets do not necessarily reflect the views of individual member organisations, unless otherwise specified.
