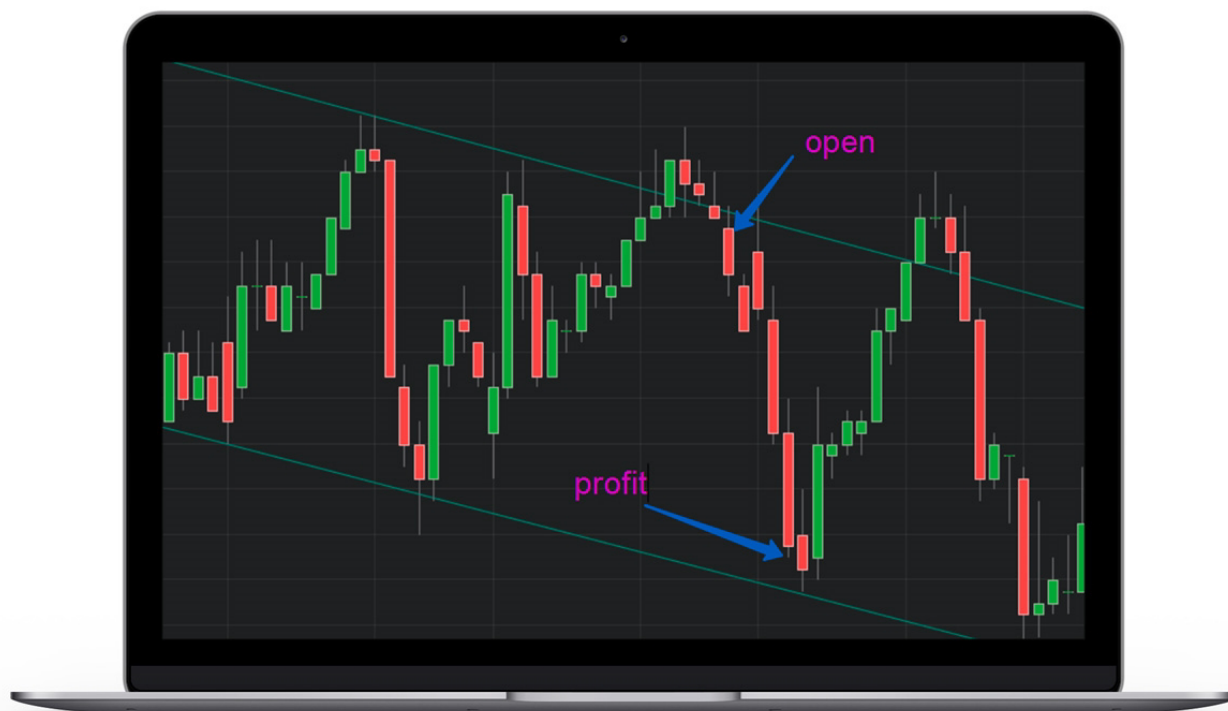
Trading report

16.10.2017 Monday

A good trend was seen on the Italy index. But due to the channel's width, the deal opened at the upper border had to be postponed the next day to wait for the take-profit. There were no surprises and the deal closed with a good profit.

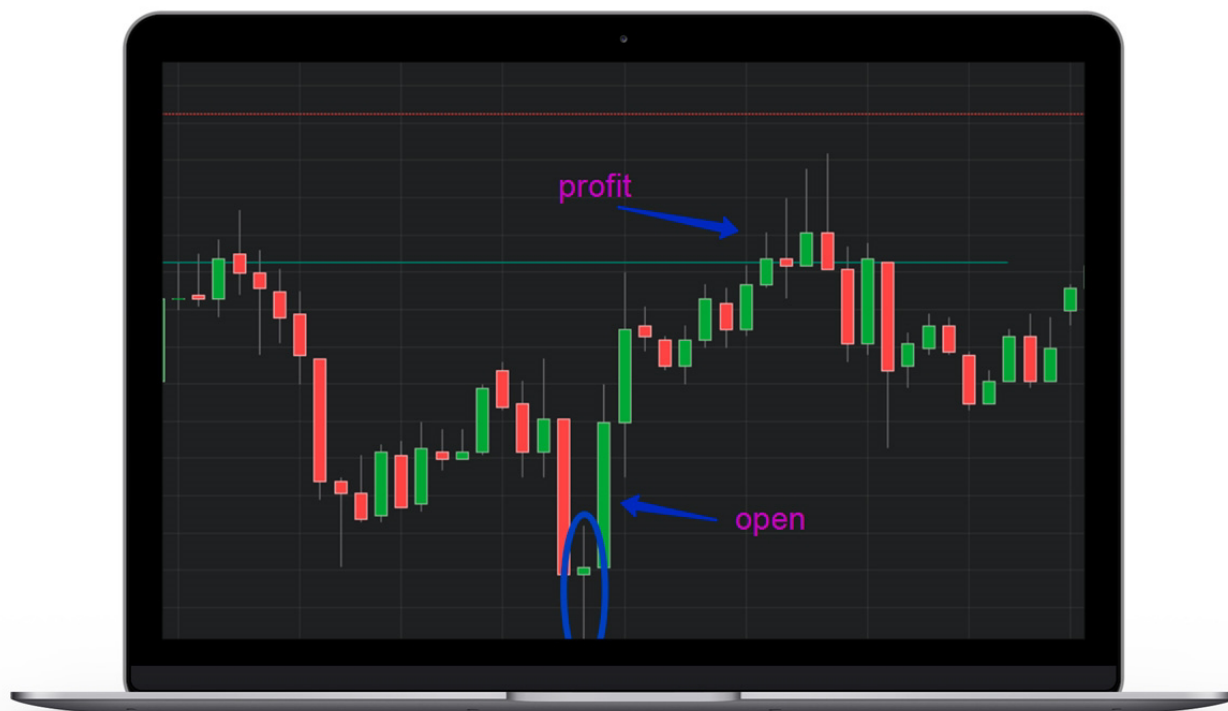

On Tuesday, the deal on the DAX index brought a 2.2% profit. The pending order was placed just above the pin bar, which pushed away from the support level. Take-profit is located at the upper border of the channel.

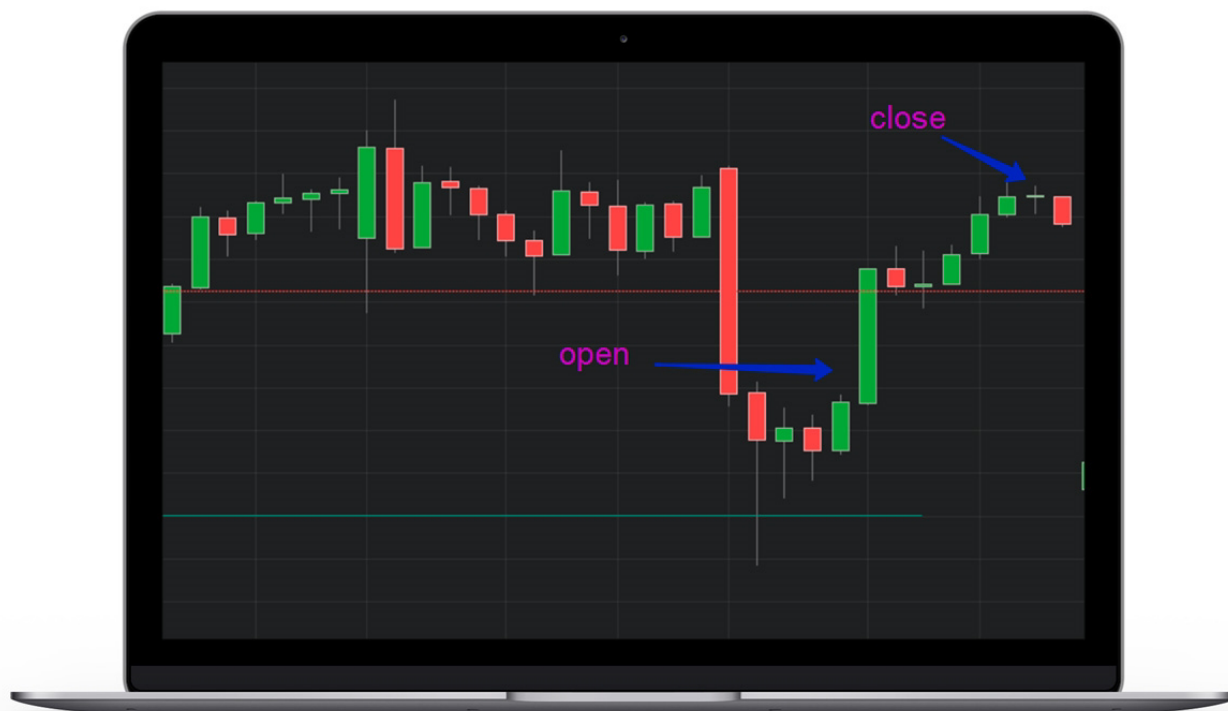

On the chart of NVIDIA shares formed pin-bar which pushed away from the support level. We put a pending purchase order just above the pattern and after three candlesticks the deal was opened. The closing was at the end of the trading day.

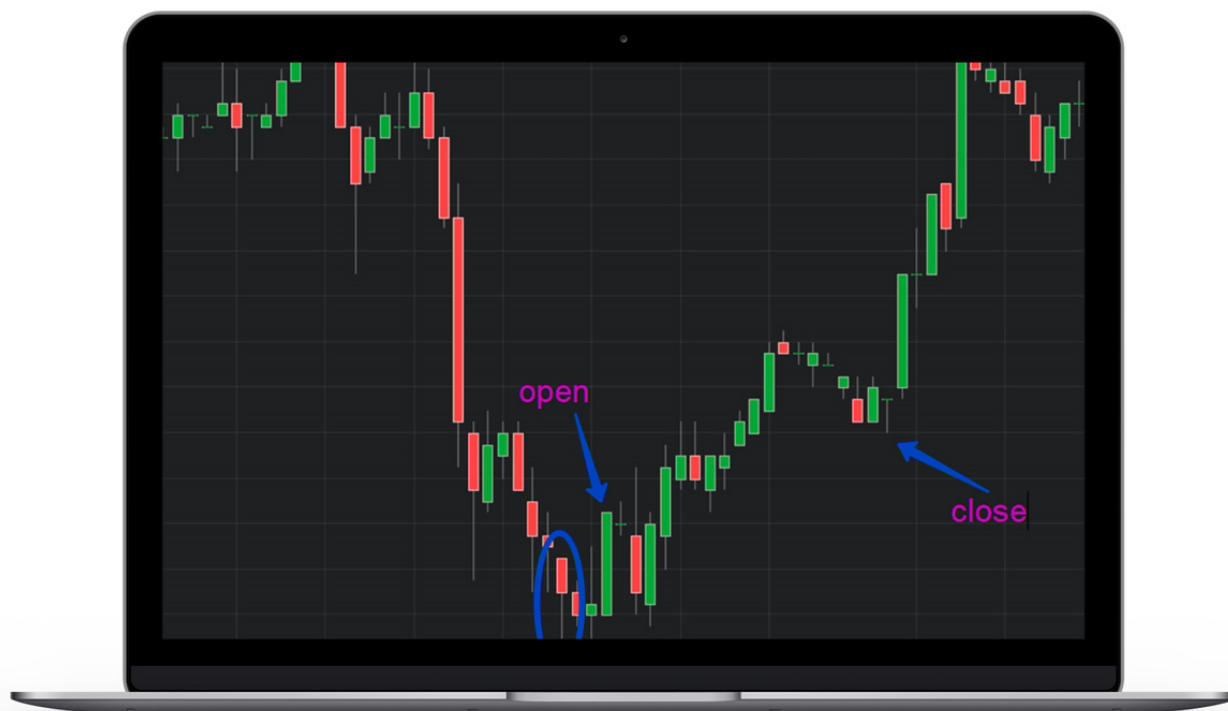

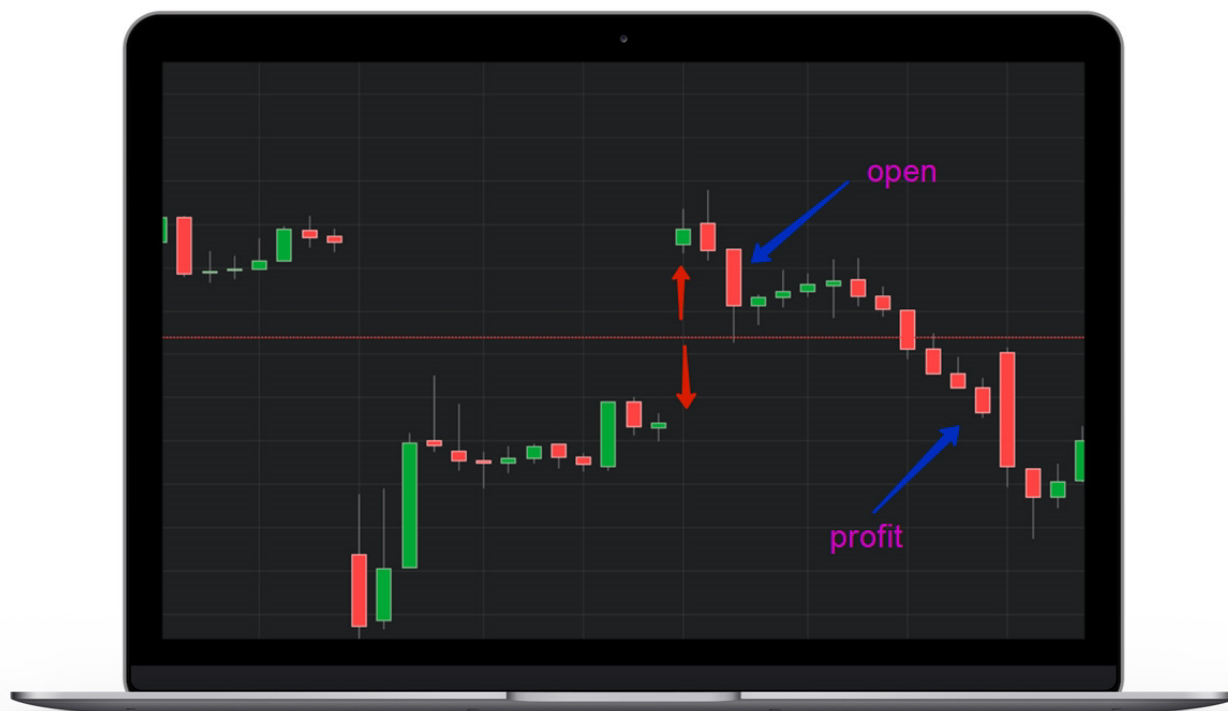

The shares of Baidu Inc. were unpredictable in recent days, on which we turned our attention. When we saw the second gap, which just fell on the level of the previous days, we immediately opened the sell order and just waited for the price to cover the gap. So it happened, the deal closed at the take-profit and brought 2.8% of the return on investment.
