Modern Slavery Act 2015 (the "Act")

This statement is the Slavery and Human Trafficking Statement of Thincats Group Limited and its subsidiary undertakings (together "**Thincats**") made pursuant to section 54 of the Act for the financial year ended 30 June 2023. A list of group companies to which this statement relates is set out at the end of this statement.

Thincats takes a zero tolerance approach to slavery and human trafficking.

Our Business

Thincats provides secured loans to small and medium sized enterprises incorporated in the United Kingdom.

Supply Chain

We do not manufacture any products nor source any commodities. Our supply chain consists mainly of software as a service suppliers, as well as other IT related supplies, office supplies and other office related services.

Risk Assessment

Given the nature of our operations, Thincats has a low risk of slavery or human trafficking occurring in its supply chain. We will assess related risks at least annually, and will do so more frequently in the event that the nature of our business or our operating environment changes.

Our Policies

We recognise our responsibility to behave ethically and treat all stakeholders fairly. We will not engage suppliers where we have reason to suspect that there is any slavery or human trafficking in their business or supply chain.

We operate a number of policies to ensure compliance with laws relating to employment rights and other human rights including:

- Anti bribery policy
- Anti harassment and bullying policy
- Disciplinary policy
- Grievance policy

During the financial period we introduced a whistleblowing policy to ensure that staff have a means of raising any serious concerns. Training was provided as part of the rollout of this policy to ensure that employees are aware that they can raise concerns anonymously and without fear of reprisal.

Due Diligence

New joiners are subject to background checks prior to joining which would identify any criminal offences relating to the Act.

We undertake due diligence on new suppliers, intermediaries and borrowers, in part to identify any risks associated with slavery or human trafficking. Contracts entered into with suppliers generally include provisions requiring all parties to comply with applicable laws and regulations. Where appropriate, we will also include more specific terms in relation to modern slavery and human trafficking (for example, in contracts with cleaning contractors).

Measuring Effectiveness

In the financial period ended 30 June 2023 there were no occurrences of modern slavery or human trafficking within the Thincats group or its suppliers.

Our Plans for 2024

At this time, we do not have any specific actions identified for 2024. We will keep this under review throughout the year. This statement was approved by the board of Thincats Group Limited on 7 November 2023 and will be reviewed annually.
